Contract Agreement for Goods

This **CONTRACT AGREEMENT** made on the ___ day of <u>June</u> 2019 between the **OFFICE OF TRANSPORTATION COOPERATIVES** (hereinafter called the "**Entity**") and **GAKKEN (PHILIPPINES), INC.**, with office address at 130 GPI Building, Aurora Blvd. cor. A. Lake St., San Juan City, Metro Manila 1500 (hereinafter called the "**Supplier**");

WHEREAS, upon the invitation of the Entity, the Supplier submitted a price quotation for the Procurement of One (1) Industrial Photocopier with Printer, in the amount of One Hundred Fifty Thousand Pesos (PhP150,000.00), inclusive of appropriate taxes and fees (hereinafter called the "Contract Price") which the Entity subsequently accepted pursuant to OTC-Bids and Awards Committee Resolution No. 018, series of 2019.

NOW THIS AGREEMENT WITNESSETH, AS FOLLOWS:

- 1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the 2016 Revised Implementing Rules and Regulations of RA No. 9184, viz:
 - (a) The **Entity's** Terms of Reference, attached as **Annex A**;
 - (b) The Entity's Annual Procurement Plan (APP) for FY 2019, attached as Annex B;
 - (c) The **Entity's** Request for Quotation dated 22 May 2019, attached as **Annex C**;
 - (d) The **Supplier's** price quotation received dated 27 May 2019, submitted as **Annex D**;
 - (e) The **Supplier's** Eligibility Requirements and all other documents/statements submitted as **Annex E**; and
 - (f) The **Entity's** Notice of Award, attached as **Annex F.**
- 2. In consideration of the payment to be made by the **Entity** to the **Supplier** as hereinbefore mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods/service, and remedy defects thereof in conformity with stipulations of the Contract in all aspects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
- 3. If the **Supplier** fails to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period(s) specified in this Contract inclusive of duly granted time extensions if any, the Procuring Entity shall, without prejudice to its other remedies under this Contract and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10th) of one percent (1%) of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Procuring Entity may rescind or terminate the Contract without prejudice to other courses of action and remedies open to it.

4. The **Supplier** shall be paid the full amount upon receipt by the Entity of a billing statement.
