## **Contract Agreement for Goods**

This **CONTRACT AGREEMENT** made on the <u>26<sup>th</sup></u> day of <u>April</u> 2023 between the **OFFICE OF TRANSPORTATION COOPERATIVES** with principal address at 5<sup>th</sup> Floor Main, Ben-Lor Building, 1184 Quezon Avenue, Brgy. Paligsahan, Quezon City 1103 (hereinafter called the "**Entity**") and **KOOP KING MULTI-PURPOSE COOPERATIVE**, with office address at Koop King Building No. 5, East Service Road, Phase 3 AFPOVAI, Western Bicutan, Taguig City, Metro Manila (hereinafter called the "**Supplier**");

WHEREAS, upon the invitation of the Entity, the Supplier submitted a price quotation for the Supply and Delivery of Sports Apparel for OTC CY 2023 Mid-Year Multi-Activities, in the amount of Fifty Thousand Eighty Two Pesos (PhP 50,082.00), exclusive of appropriate taxes and fees (hereinafter called the "Contract Price") which the Entity subsequently accepted pursuant to OTC-Bids and Awards Committee Resolution No. 003, series of 2023.

## NOW THIS AGREEMENT WITNESSETH, AS FOLLOWS:

- 1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the 2016 Revised Implementing Rules and Regulations of RA No. 9184, viz:
  - (a) The Entity's Terms of Reference, attached as Annex A;
  - (b) The **Entity's** Supplemental/Addendum of Annual Procurement Plan (APP) for FY 2023, attached as **Annex B**;
  - (c) The **Entity's** Request for Quotation dated 04 April 2023, attached as **Annex C**;
  - (d) The **Supplier's** price quotation received dated 14 April 2023, submitted as **Annex D**;
  - (e) The **Supplier's** Eligibility Requirements and all other documents/statements submitted as **Annex E**; and
  - (f) The **Entity's** Notice of Award, attached as **Annex F.**
- 2. In consideration of the payment to be made by the **Entity** to the **Supplier** as hereinbefore mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods/service, and remedy defects thereof in conformity with stipulations of the Contract in all aspects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
- 3. If the **Supplier** fails to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period(s) specified in this Contract inclusive of duly granted time extensions if any, the Procuring Entity shall, without prejudice to its other remedies under this Contract and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth  $(1/10^{th})$  of one percent (1%) of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Procuring Entity may rescind or terminate the Contract without prejudice to other courses of action and remedies open to it.
- 4. The **Supplier** shall be paid the full amount within 30 days upon receipt by the Entity of Sales Invoice and Delivery Receipt.
