

Contract Agreement Form for the Procurement of Goods (Revised)

CONTRACT AGREEMENT

THIS AGREEMENT made the OCT 19 2023 day of _____ 2023 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and JOLLIBEE FOODS CORPORATION of Pasig City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Catering Services for the 50th Golden Anniversary Celebration of the Transport Cooperative Program in the City of San Jose del Monte, Bulacan**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Ninety-Five Thousand Five Hundred Fifty Pesos (PhP 95,550.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Special Conditions of Contract;
 - iv. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - v. Performance Security;
 - vi. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Ninety-Five Thousand Five Hundred Fifty Pesos (PhP 95,550.00)** or such other sums as may be ascertained, **JOLLIBEE FOODS CORPORATION** agrees to **Catering Services for the 50th Golden Anniversary Celebration of the Transport Cooperative Program in the City of San Jose del Monte, Bulacan** in accordance with its Bid.
4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


