

# Contract Agreement Form for the Procurement of Goods (Revised)

## CONTRACT AGREEMENT


**THIS AGREEMENT** made the \_\_\_\_\_ day of \_\_\_\_\_ 2023 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and LA BREZA HOTEL INC. of Quezon City, Philippines (hereinafter called "the Lessor") of the other part;

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly **Lease of Venue inclusive of Meals for the Two (2) Day 2023 Agency and Employee's Performance Review of the Office of Transportation Cooperatives (OTC)** to be held on December 11 and 18, 2023, and has accepted a Bid by the Lessor for the supply of those goods and services in the sum of **One Hundred Seven Thousand Eight Hundred Pesos (PhP 107,800.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of One Hundred Seven Thousand Eight Hundred Pesos (PhP 107,800.00) or such other sums as may be ascertained, LA BREZA HOTEL, INC. agrees to Lease of Venue inclusive of Meals for the Two (2) Day 2023 Agency and Employee's Performance Review of the Office of Transportation Cooperatives (OTC) to be held on December 11 and 18, 2023 in accordance with its Technical Specifications.
4. The OFFICE OF TRANSPORTATION COOPERATIVES agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
