RECOMMENDING THE AWARD OF CONTRACT TO PINGCON MARKETING CORPORATION FOR THE PROCUREMENT OF FORTY-EIGHT (48) PACKS OF GOODS PACKAGE FOR OTC OFFICIALS AND EMPLOYEES.


"**WHEREAS**, the authorized Team, namely: Ms. Pearl Jane F. Baculi (OTC-BAC Member), Mr. Delfin P. Aquino (TWG Member), Ms. Angelica J. Aspero (End-User Representative), and Mr. Francis Emmanuel S. Balcita (OTC-BAC Secretariat) conducted the Post-Qualification Proceedings and Ocular Inspection to Pingcon Marketing Corporation dated 24 November 2023;"


"**WHEREAS**, based on the submitted mandatory post-qualification report and recommendation made by the Team, the OTC-BAC after a judicious and careful deliberation finds the Bid Price offer of **PINGCON MARKETING CORPORATION**, together its verified eligibility documents, is indeed compliant to all the procurement requirements of the Procuring Entity, hence, the lone bidder is Post-Qualified;"

"**WHEREAS**, the OTC-BAC finds the entire procurement project in strict compliance, and in accordance the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, and justifiable of being elevated to the Head of the Procuring Entity (HoPE) for his final action;"

"**NOW THEREFORE**, for and in consideration of the foregoing, **WE**, the Members of the OTC-BAC, by virtue of the powers vested on **US** by law, hereby resolve to **RECOMMEND** to the Head of the Procuring Entity (HoPE) and Chairperson of OTC to **AWARD THE CONTRACT** to **PINGCON MARKETING CORPORATION** *via* Negotiated Procurement-Two Failed Biddings (Sec. 53.1) FOR THE PROCUREMENT OF FORTY-EIGHT (48) PACKS OF GOODS PACKAGE FOR OTC OFFICIALS AND EMPLOYEES in the amount of Two Hundred Thirty-Nine Thousand Nine Hundred Eighty Eight Pesos and Forty Eight Centavos (**Php 239,988.48**), inclusive of appropriate EWT and VAT withholding taxes, and is within the Approved Budget for the Contract (ABC) in the amount of Php 240,000.00;




