CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of ____ 2024 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and U.P. NATIONAL CENTER FOR TRANSPORTATION STUDIES FOUNDATION, INC. (UP-NCTSFI) of Quezon City, Philippines (hereinafter called "the Service Provider") of the other part;


WHEREAS, the Entity invited to submit Quotation for certain goods and ancillary services, particularly **Procurement of Learning Service Provider of Basic Fleet Management System Seminar**, and has accepted a quotation from the Service Provider for the supply of those goods and services in the sum of **Two Million Four Hundred Thousand Pesos (PhP 2,400,000.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 
1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Price Quotation Form (Annex A);
 - ii. Schedule of Requirements (Annex B);
 - iii. Technical Requirements (Annex C);
 - iv. Conformity with the Terms of Reference (Annex C-1);
 - v. Service Provider's Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - vi. Eligibility form, including all the documents/statements contained in the envelopes, as annexes, and all other documents submitted, including corrections to the quotation, if any, resulting from the Procuring Entity's quotation evaluation;
 - vii. Notice of Award of Contract; and the Service Provider's conforme thereto; and
 - viii. Other contract documents that may be required by existing laws and/or the Procuring Entity. **Service Provider agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the** contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.
 3. In consideration for the sum of Two Million Four Hundred Thousand Pesos (PhP 2,400,000.00) or such other sums as may be ascertained, UP-NCTSFI agrees to the *Procurement of Learning Service Provider of Basic Fleet Management System Seminar* in accordance with the agreement.
 4. The OFFICE OF TRANSPORTATION COOPERATIVES agrees to pay the above-mentioned sum in accordance with the terms of the agreement.

5. The parties to this agreement agree to the co-ownership of the intellectual property produced from this agreement and undertaking. Its individual or joint use, other than those stated in the Schedule of Requirements, shall be stated in a separate document formulated and approved by the parties.






