

## Contract Agreement Form for the Procurement of Goods (Revised)

### CONTRACT AGREEMENT

**THIS AGREEMENT** made the 05 day of AUG 2024 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and BLUE SAPPHIRE SOCIAL EVENTS CORP. of Lipa City in Batangas, Philippines (hereinafter called "the Lessor") of the other part;


**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly **Lease of Venue inclusive of Meals for the Drivers Training on Road Safety and Ethics in Batangas** to be held on August 14-15, 2024, and has accepted a Bid by the Lessor for the supply of those goods and services in the sum of **Two Hundred Fifty-Five Thousand Pesos (Php 255,000.00)** (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Two Hundred Fifty-Five Thousand Pesos (Php 255,000.00)** or such other sums as may be ascertained, **BLUE SAPPHIRE SOCIAL EVENTS CORP.** agrees to **Lease of Venue inclusive of Meals for the Drivers Training on Road Safety and Ethics in Batangas** to be held on August 14-15, 2024 in accordance with its Technical Specifications.
4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


