

# Contract Agreement Form for the Procurement of Goods (Revised)

## Supply and Delivery of Fifty (50) Laptop Computers

### CONTRACT AGREEMENT

THIS AGREEMENT made the \_\_\_\_\_ day of JUL 31 2024 2024 between the **OFFICE OF TRANSPORTATION COOPERATIVES** of the Philippines (hereinafter called "the Entity") of the one part and **REMAX INTERNATIONAL, INC.** of Pasig City, Philippines (hereinafter called "the Supplier") of the other part;

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Fifty (50) Laptop Computers** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Four Hundred Eighty-Seven Thousand Five Hundred Pesos (PhP 3,487,500.00)** (hereinafter called "the Contract Price").


#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
  - i. The duly accomplished Philippine Bidding Documents (PBDs) submitted by the **Supplier** dated 24 June 2024, and acknowledged by the **Entity**, attached as **Annex A**;
    - i. The Conformity with the Terms of Reference and Detailed Technical Specifications with Bid Bulletin No. 01-2024;
    - ii. The Schedule of Requirements;
    - iii. The General and Special Conditions of the Contract;
  - ii. The Bid Notice Abstract (Invitation to Bid) published by the **Entity** on 03 June 2024, attached as **Annex B**;
  - iii. The Performance Security submitted by the **Supplier**, attached as **Annex C**;
  - iv. The **Entity's** Notice of Award, with the **Supplier's** conforme thereto, attached as **Annex D**;
  - v. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - vi. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring **Entity's** bid evaluation;
  - vii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.



3. In consideration for the sum of **Three Million Four Hundred Eighty-Seven Thousand Five Hundred Pesos (PhP 3,487,500.00)** or such other sums as may be ascertained, **REMAX INTERNATIONAL, INC.** agrees to the **Supply and Delivery of Fifty (50) Laptop Computers** in accordance with its Bid.
4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




