

## **OTC-BIDS AND AWARDS COMMITTEE**

### **Resolution No. 041, Series of 2024**

#### **RECOMMENDING THE AWARD OF CONTRACT TO BATAAN WHITE CORAL'S BEACH RESORT INC. FOR THE LEASE OF VENUE INCLUSIVE OF MEALS AND ACCOMMODATION FOR THE OTC ANNUAL AGENCY AND IMPLEMENTATION OF PUBLIC TRANSPORT MODERNIZATION PROGRAM ACTIVITIES PERFORMANCE REVIEW IN BATAAN.**

**"WHEREAS**, the Office of Transportation Cooperatives' Program Implementing Unit (PIU) for the Public Transport Modernization Program (PTMP) as the End-User, prepared the Terms of Reference (ToR), Project Procurement Management Plan (PPMP), and the Purchase Request (PR) (**Annex A**); for the Lease of Venue Inclusive of Meals and Accommodation for the OTC Annual Agency and Implementation of Public Transport Modernization Program Activities Performance Review to be held on December 10 to 13, 2024 in Bataan with an Approved Budget of the Contract (ABC) amounting to PHP 1,225,000.00 which is included in the Supplemental Annual Procurement Plan (APP) for Fiscal Year 2024 (**Annex B**);"

**"WHEREAS**, on 30 October 2024, the OTC-Bids and Awards Committee (OTC-BAC) directed the BAC-Secretariat to electronically transmit (e-mail) the approved Request for Quotations (RFQs) using its official e-mail address to the different tourist bus services on which the deadline of submission of quotations was set on 06 November 2024, 12:00 P.M. The complete catalogue of nine (9) prospective suppliers is attached as (**Annex C**);"

**"WHEREAS**, before the closing date and time of the submission of the RFQs on 06 November 2024, 12:00 P.M., two (2) interested suppliers submitted their RFQ electronically: 1) Juness Beach Resort and 2) Bataan White Coral's Beach Resort, Inc. The OTC-BAC formally evaluated the said RFQ of the supplier at a meeting held at the OTC Conference/Board Room on 06 November 2024, 01:00 PM. Juness Beach Resort have incomplete requirements, no Income Tax Return (ITR), no Secretary's Certificate and have not comply with the technical specifications and is therefore failed pursuant to Sec. 30.2 of the 2016 RIRR of RA No. 9184;"

**"WHEREAS**, after a careful review, evaluation, and deliberation among the members of the Committee, it has hereby concluded that Bataan White Coral's Beach Resort, Inc. passed and complied with the legal, technical, and financial requirements of the OTC as the Procuring Entity (**Annex D**); The supplier's Price Quotation Offer amounting to One Million One Hundred Seventy Thousand Pesos (Php 1,170,000.00), inclusive of applicable EWT and VAT government withholding taxes which is within the ABC of Php 1,225,000.00, is economical and advantageous to the government and recognized by the OTC-BAC to be the Single Calculated Quotation (SCQ) (**Annex E**);"


**"WHEREAS**, the OTC-BAC was mandated to facilitate other means of inspection to the supplier, hence, after judicious review and deliberations of the submitted tabulated Table of Rating Factors for Lease of Venue, the average rating of the said resort was 89.35% (marked as passed), the OTC-BAC declared that Bataan White Coral's Beach Resort, Inc. is the Single Calculated and Responsive Quotation (SCRQ) (**Annex E**);


**"WHEREAS**, pursuant to Section 12 of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA No. 9184 otherwise known as the Government Procurement Reform Act (GPRA) mandates that the OTC-BAC shall recommend the award of contract to the Head of the Procuring Entity (HoPE) or his/her duly authorized representative;

**NOW, THEREFORE,** for and in consideration of the foregoing, **WE,** the Members of the OTC-BAC, by virtue of the powers vested on **US** by law, hereby resolved to **RECOMMEND** to the Head of the Procuring Entity (HoPE) and Chairperson of OTC the following:


- 1) **AWARD OF CONTRACT** *via* Negotiated Procurement-Lease of Venue (Section 53.10) to Bataan White Coral's Beach Resort, Inc. as the Single Calculated Responsive Quotation (SCRQ) for the Lease of Venue, Inclusive of Meals and Accommodation for the OTC Annual Agency and Implementation of Public Transport Modernization Program Activities Performance Review to be held on December 10 to 13, 2024 in Bataan amounting to One Million One Hundred Seventy Thousand Pesos (**Php 1,170,000.00**), inclusive of applicable EWT and VAT government withholding taxes; and
- 2) **SIGN AS HEAD OF THE PROCURING ENTITY** the corresponding Notice of Award and Notice to Proceed to implement this Resolution.


