CONTRACT AGREEMENT AUG 2 2 2024

THIS AGREEMENT made the ____ day of ____ 2024 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and HOTEL LUCKY CHINATOWN of City of Manila, Philippines (hereinafter called "the Lessor") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Lease of Venue inclusive of Accommodation and Meals for Workshop of the Basic Fleet Management System Seminar in Quezon City or City of Manila to be held on August 22-23, and has accepted a Bid by the Lessor for the supply of those goods and services in the sum of Ninety-Seven Thousand Five Hundred Pesos (Php 97,500.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Ninety-Seven Thousand Five Hundred Pesos* (*Php* 97,500.00) or such other sums as may be ascertained, *HOTEL LUCKY CHINATOWN* agrees to *Lease of Venue inclusive of Accommodation and Meals for Workshop of the Basic Fleet Management System Seminar in Quezon City or City of Manila* to be held on August 22-23, 2024 in accordance with its Technical Specifications.
- 4. The OFFICE OF TRANSPORTATION COOPERATIVES agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
