CONTRACT AGREEMENT


THIS AGREEMENT made the **NOV 25 2024** day of _____ 2024 between the **OFFICE OF TRANSPORTATION COOPERATIVES** of the Philippines (hereinafter called "**BUYER**") of the one part and **AVID SALES CORPORATION** of Quezon City, Philippines (hereinafter called "**SUPPLIER**") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY AND DELIVERY OF A VIDEO CONFERENCING SYSTEM AND INTERACTIVE DISPLAY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Ninety-Five Thousand Pesos (PhP 495,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iv. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - v. Notice of Award of Contract, and the Bidder's *conformé* thereto, and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Four Hundred Ninety-Five Thousand Pesos (PhP 495,000.00)** or such other sums as may be ascertained, **AVID SALES CORPORATION** agrees to the **Supply and Delivery of a Video Conferencing System and Interactive Display** in accordance with its Technical Specifications.
4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




