

Contract Agreement Form for the Procurement of Goods (Revised)

CONTRACT AGREEMENT

THIS AGREEMENT made the SEP 27 2024 day of 2024 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and SENG'S CANTEEN & CATERING SERVICES of Tarlac City in Tarlac, Philippines (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited through the Request for Quotation (RFQ) for certain goods and ancillary services, particularly **Catering Services for the Drivers Training on Road Safety and Ethics in Tarlac City, Tarlac** to be held on September 18-19, 2024, and has accepted a Quotation by the Supplier for the supply of those goods and services in the sum of **Ninety-Six Thousand Eight Hundred Pesos (Php 96,800.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Winning supplier's price quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Price Quotation Form, including all the documents/statements contained in the Supplier's Quotation envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's quotation evaluation;
 - iv. Notice of Award of Contract; and the Supplier's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Quotation. The winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of *Ninety-Six Thousand Eight Hundred Pesos (Php 96,800.00)* or such other sums as may be ascertained, *SENG'S CANTEEN & CATERING SERVICES* agrees to *Catering Services for the Drivers Training on Road Safety and Ethics in Tarlac City, Tarlac* to be held on September 18-19, 2024 in accordance with its Technical Specifications.
4. The *OFFICE OF TRANSPORTATION COOPERATIVES* agrees to pay the above-mentioned sum in accordance with the terms of the agreement.






