

Contract Agreement Form for the Procurement of Goods (Revised)

CONTRACT AGREEMENT
NOV 29 2024

THIS AGREEMENT made the _____ day of _____ 2024 between the OFFICE OF TRANSPORTATION COOPERATIVES of the Philippines (hereinafter called "the Entity") of the one part and BATAAN WHITE CORALS BEACH RESORT INC. of Morong, Bataan Philippines (hereinafter called "the Lessor") of the other part;

WHEREAS, the Entity invited Quotations for certain goods and ancillary services, particularly **Lease of Venue, Inclusive of Meals and Accommodation for the OTC Annual Agency and Implementation of Public Transport Modernization Program Activities Performance Review in Bataan** to be held on December 10 to 13, 2024, and has accepted a Quotation by the Lessor for the supply of those goods and services in the sum of **One Million One Hundred Seventy Thousand Pesos (Php 1,170,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Winning supplier's quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Quotation form, including all the documents/statements contained in the Supplier's quotation, as annexes, and all other documents submitted, including corrections to the quotation, if any, resulting from the Procuring Entity's evaluation of quotation;

- iv. Notice of Award of Contract; and the Lessor's conformé thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.



In consideration for the sum of *One Million One Hundred Seventy Thousand Pesos (Php 1,170,000.00)* or such other sums as may be ascertained, BATAAN WHITE CORALS BEACH RESORT INC. agrees to the *Lease of Venue, Inclusive of Meals and Accommodation for the OTC Annual Agency and Implementation of Public Transport Modernization Program Activities Performance Review in Bataan*, to be held on December 10 to 13, 2024 in accordance with its Technical Specifications.
4. The OFFICE OF TRANSPORTATION COOPERATIVES agrees to pay the above-mentioned sum in accordance with the Terms of Reference and Contract.






