Quotation form, including all the documents/statements contained in the Supplier's quotation, as annexes, and all other documents submitted, including corrections to the quotation, if any, resulting from the Procuring Entity's evaluation of quotation;

- iv. Notice of Award of Contract; and the Supplier's conformé thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Forty-Four Thousand Pesos (Php 44,000.00) or such other sums as may be ascertained, EGI ALBERGO INC. agrees to Lease of Venue inclusive of Meals with Complete Facilities for the Regional TC PTMP Compliance Monitoring Action Scheming Conference in Cordillera Administrative Region to be held on November 28, 2024 in accordance with its Technical Specifications.
- The OFFICE OF TRANSPORTATION COOPERATIVES agrees to pay the abovementioned sum in accordance with the Terms of Reference and Contract.
