- iv. Notice of Award of Contract; and the Supplier's conformé thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Hundred Fourteen Thousand Six Hundred Sixty Pesos (Php 114,660.00) or such other sums as may be ascertained, VMB REALTY INC. agrees to Lease of Venue inclusive of Meals with Complete Facilities for the Regional TC PTMP Compliance Monitoring Action Scheming Conference in Tacloban-Region VIII to be held on November 07, 2024 in accordance with its Technical Specifications.


