  - v. Notice of Award of Contract, and the Bidder's conformé thereto, and
  - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Hundred Seventy-Five Thousand Pesos (PhP 175,000.00) or such other sums as may be ascertained, ALPHABET COMMUNICATIONS GRAPHICS AND PRINT agrees to the Procurement of Public Transportation Modernization Program (PTMP) Special Report Printing Services in accordance with its Technical Specifications.
