CONTRACT AGREEMENT

THIS AGREEMENT made the MAY 27 2025 day of MAY 27 2025 2025 between the **OFFICE OF TRANSPORTATION COOPERATIVES** (hereinafter called "the Entity") and the **NLCC TOURS AND TRANSPORT SERVICES** of Cainta, Rizal, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Quotations for certain goods and ancillary services, particularly **Procurement of Transportation Services for the OTC 2025 Strategic Plan and Revised Operational Manual Presentation, Team Building And GAD Activity** to be held on May 28 to 30, 2025, and has accepted a Quotation by the Supplier for the supply of those goods and services in the sum of **Forty-Four Thousand Eight Hundred Pesos (Php 44,800.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. Winning supplier's quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Quotation form, including all the documents/statements contained in the Supplier's quotation, as annexes, and all other documents submitted, including corrections to the quotation, if any, resulting from the Procuring Entity's evaluation of quotation;

- iv. Notice of Award of Contract; and the Supplier's conformé thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Forty-Four Thousand Eight Hundred Pesos (Php 44,800.00)** or such other sums as may be ascertained, **NLCC TOURS AND TRANSPORT SERVICES** agrees to the *Procurement of Transportation Services for the OTC 2025 Strategic Plan and Revised Operational Manual Presentation, Team Building And GAD Activity*, to be held on May 28-30, 2025 in accordance with its Technical Specifications.
4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the Terms of Reference and Contract.
