CONTRACT AGREEMENT

Quotation form, including all the documents/statements contained in the Supplier's quotation, as annexes, and all other documents submitted, including corrections to the quotation, if any, resulting from the Procuring Entity's evaluation of quotation:

- Notice of Award of Contract; and the Supplier's conformé thereto;
 and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning supplier agrees that additional contract documents or information prescribed by the Entity that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Forty-Four Thousand Eight Hundred Pesos (Php 44,800.00) or such other sums as may be ascertained, NLCC TOURS AND TRANSPORT SERVICES agrees to the Procurement of Transportation Services for the OTC 2025 Strategic Plan and Revised Operational Manual Presentation, Team Building And GAD Activity, to be held on May 28-30, 2025 in accordance with its Technical Specifications.
- 4. The **OFFICE OF TRANSPORTATION COOPERATIVES** agrees to pay the above-mentioned sum in accordance with the Terms of Reference and Contract.
