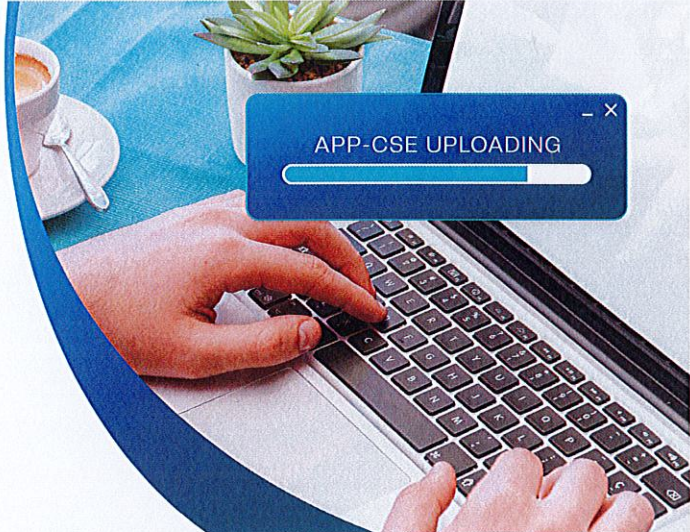

Only agencies with uploaded APP-CSE in the Modernized Philippine Government Electronic Procurement System (mPHAGES) will be able to purchase CSE from the PS-DBM.

Note that the items listed on this form have been arranged in accordance with the United Nations Standard Products and Services Code (UNSPSC).

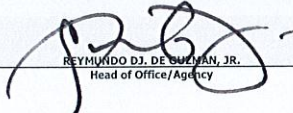
